The researcher conducted this study at Notre Dame of Tacurong College towards 262 college students across all year levels and courses who were enrolled during the first semester of the academic year 2016-2017 as the respondents. The researcher uses convenient sampling to identify the individual respondents from each class and a researchermade questionnaire to gather data for this study. The researcher uses different statistical tools such as frequency, percentage, mean, standard deviation, and ranking to treat the data. Findings reveal that out of 262 respondents, most are female second-year students enrolled in Bachelor of Science in Business Administration. Results show further that college students' perspective on teachers' work ethics generally practices to a great extent are lecturers use technology when teaching; lecturers dress appropriately in school; lecturers abide by the school policies, and lecturers show positive relationship towards school administration. Also, lecturers manage students' misbehaviour with patience.

However, "Teachers return to the students corrected exams, quizzes, assignments, and other written class activities" obtained the lowest mean and interpreted as To a Moderate Extent. This finding implies that there are instances that teachers cannot return written class requirements in which students find it frustrating. This finding is somewhat contrary to what (Park & Hill, 2020). contends that a good employee or teacher should manage time wisely, emphasize punctuality, and observe deadlines. This finding implies that some teachers have to strengthen this work ethic on the promptness of giving feedback on students ' performance.

Furthermore, students prefer that their "Teachers come to class on time." This finding points to the importance of time management. According to Park & Hill (2020), being punctual in reporting to work, and in this situation, to the class is an indicator of a good work ethic. Being punctual in starting the course means more instructional time, which is equivalent to having more time to teach on the part of the teacher and more time to learn on the part of the students.

4. CONCLUSION

Based on the study's significant findings, the researcher concluded that college students of Notre Dame of Tacurong College find their teachers' work ethics to be generally solid since they have practiced these to a great extent. However, the researcher found that there are work ethics that should be strengthened. Hence, it is recommended that school administrators should remind their faculty to report to their classes on time and return to the students, checked exams, quizzes, assignments, and other written class activities.
